RE: MATCH VENUE – SPORTPESA LEAGUE MATCH NO. 293, MARA SUGAR FC VS GOR MAHIA FC

We acknowledge receipt of your mail regarding the subject matter.

The Leagues & Competitions Committee, upon review of your request, wishes to communicate as follows:

Rule 18 of the FKF Rules & Regulations Governing Kenyan Football (2025) provides that *“Each team participating in an FKF league shall propose a home venue and an alternative venue for its home games. Where practical, the alternative venue shall be within the same zone (not more than 200kms) as the first proposed home venue.”*

In the alternative, and without prejudice, Rule 3.1.5 of the FKF Rules & Regulations Governing Kenyan Football (2019) provides as follows;

In all the FKF Leagues:

- *Each team shall name its home ground as well as its alternative home ground. In the event of neither venue being suitable, FKF will have a right to fixture a match at an alternative ground at its absolute discretion;*
- *If, for any reason, a team is unable to play its home fixture at its home ground, it may apply to play its fixtures at a ground selected as an alternative home ground or at a neutral venue to be determined by FKF;*
- *Each team will register its home ground (s) with FKF and no team will relocate to another ground without prior written consent of FKF, which consent will not be unreasonably withheld;*

Documents in possession of the FKF and seen by the Committee indicate the below venues as registered by your club to host your league matches for the 2025/2026 Season;

1. *Primary Home Venue: Green Stadium, Awendo*
2. *Alternative Home Venue: Raila Odinga Stadium, Homabay*
3. *2nd Alternative Venue: Jomo Kenyatta Stadium, Mamboleo*



The Committee notes that your choice of venue to host the match was neither registered as your alternative venue nor your second alternative venue. In addition, the venue is more than 200kms from your primary home venue.

In view of the aforementioned, the Committee regrets to inform you that the request to have the match moved to Wang'uru Stadium in Mwea has been declined.

Further, and guided by the Regulations and the document submitted by your club (attached herein), please be informed that the match shall be played as follows;

Match No. 293: Mara Sugar FC vs Gor Mahia FC

Date: Sunday, 24th May 2026

Venue: Raila Odinga Stadium, Homabay

Kick-off: 1400Hrs

The above decision has been made in the interest of the game and in upholding the Competitions' Rules & Regulations.
